CROWN WRIT # 4

Ed note: Their Majesties have included information from the Bylaws of the Adrian Empire and as well as adding new information.

The formation of Estates shall require the swearing in of its members. This shall be in addition to meeting all of the requirements set forth in the Bylaws. Houses shall require a minimum of 3/5 of all listed members by person or written proxy present in court for the creations of new estates. All members wishing to join an existing Estate must swear in at Court (this being a sanctioned event) or give written proxy to the Chancellor.

Note: Baronies, Counties or Marches being formed with lesser Estates must meet the 3/5th rule

Note: if it is being formed by lesser estates, all heads of Estates must be present in person or by proxy and provide an up to the date list of the members, signatures not necessary on the list.

In order to avoid confusion, any time there is an Estate movement change, a roster of all estate members must be provided.

Royal Family – Sir Knight Hawk le Treson, Earl of Adira, Sir James the Red, Earl of Northumberland and Dame Aislynn de Chartier, Countess Royal Umbria

Sir Richard Corazon del Oso announced that he had received a pressing message from Cu Locksley Forge calling them forth. Sir Stephan Cridhe cu Locksley and procession brought forth the Crown Jewels. Which were then presented to Dame Nisha Rosalia.
